Will be serviced by THE STALLION "Boss' Midnight Cash" MFTHBA Registration Number #02-72516 a Black stallion, standing for 4 P's Ranch owned by Harry Patterson of Wichita Falls, TX and standing in Marshfield, MO at Free Rein Farms here after in this contract known as 4 P's Ranch Representative, is bred with a Limited, Live Foal Guarantee. Stud Fee for 2012 is \$500.00 plus mare care (Dry \$10.00 a day and Wet of \$15.00). Stud Fee must be paid in advance before breeding and Mare Care fees and Veterinarian fees will be paid before Mare is released to owner. In unlikely event a dead foal is born, the mare in this contract will be serviced again at no additional breeding fee but mare/foal care fees will apply. These fees are not refundable. Please make all checks payable to Patterson Properties the Stallion Owner.

A blood test may be required to verify parentage by our veterinarian at our expense.

4 P's Ranch/Free Rein Farms Representative agrees to:

1. Service the mare, up to three times to settle her for the \$500.00 breeding fee plus mare care and veterinarian fees.

Or

2. Service a substitute mare at no additional fee if the mare in this contract dies or is deemed unfit for breeding by a licensed veterinarian.

We will not breed a mare unless it is "deemed fit" to breed by a licensed veterinarian.

If after the first round of live breeding's your mare does not settle a culture of the mare will be required breed the second heat cycle at your expense.

Once your mare is bred we STRONGLY Recommend that you take her home and let her rest, do not exert her until she has been checked by your veterinarian at 16 days for an embryo and your vet clears her for normal activities. This will lessen the chances of her absorbing the embryo and settling like she should.

Breeding certificate (Stallion Service MFTHBA Certificate) issued by 4 P's Ranch/Free Rein Farms Representative ONLY after foal is born and color photo of foal sucking mare is received at 4 P's Ranch.
